Getting There

By Car:

From I-495/Capital Beltway: Exit at either Georgia Avenue/North or Connecticut Avenue/North. (Going north, Connecticut Avenue ends in Leisure World.)

The Leisure World community has three gates: one at Connecticut Avenue, one at the main entrance on Georgia Avenue at Rossmoor at the big globe (two lights north of Connecticut Avenue, two lights south of Norbeck Road) and one on Norbeck Road/Route 28 at Norbeck Boulevard.

At the Leisure World gate, tell the guard you are attending the Sisters in Crime meeting or the Collins meeting at Fairways South.

Then, from the gate:

From the main gate at Rossmoor: Go through the gate, take a left at the stop sign onto N. Leisure World Blvd., drive about a 1/2 mile, turn right into the driveway with the "Fairways 3330" sign.

From the Connecticut Ave gate: Proceed through the gate, turn left at the stop sign onto S. Leisure World Blvd. for about one mile, turn right into the driveway with "Fairways 3330" sign.

From the Norbeck Road gate: Drive through the gate, turn right at the stop sign onto N. Leisure World Blvd. to the second high-rise building, take a left into the driveway opposite Hyde Park Drive. After turning, you will see the "Fairways 3330" sign on your left.

Someone from the chapter will be in the lobby to let you in from the vestibule. Turn left at the elevators, then right to the party room.

Free parking is available.
